**Notification of Distribution Sources  
Pursuant to Rule 19a-1 under the Investment Company Act of 1940**

As noted in the table below, NexPoint Real Estate Strategies Fund (the “Fund”) is making a distribution payable on December 31, 2022, a portion of which is estimated to be in excess of the Fund’s current and accumulated undistributed net income.
