## Important Last Week


## **A Quiet Week**

- Leadership diverging potential bullish 'wedge'
- Gold remains firm, after 'bear trap'
- Worked well during 70's, and during stagflation

- ✓ Bounce & test that low

## Commodities / US\$:


- Commodities strong up 2x since Mar'20

- 'Stagflation' a very real worry

#### **Yields / Credit:**

- 10-yr. finding support in 3½% area
- 3-mo. / 10-yr. curve <u>solidly</u> inverted
- Corp. credit improving meaningfully

## Stocks:

- Saw a cyclical top, and a 'bear market'
- Market trying to form a cyclical bottom
- Again failed at down trendlines
- Still a real chance of secular bear
