Important Last Week

Strength in Market!

- S&P 500 pressing July highs
- Internals strong, confirming indices
- Tech sector is leading the way higher
- Fresh breakout in financial sector
- Now seeing laggards 'catch-up'
- 'Bear Trap' confirmed on the chart
- Moving into a strong period seasonally

Strength in Metals?

- Significant reversals in prec. metals
- Silver reversed the strength of prior week, copper & gold trying to hold

Commodities / US\$:

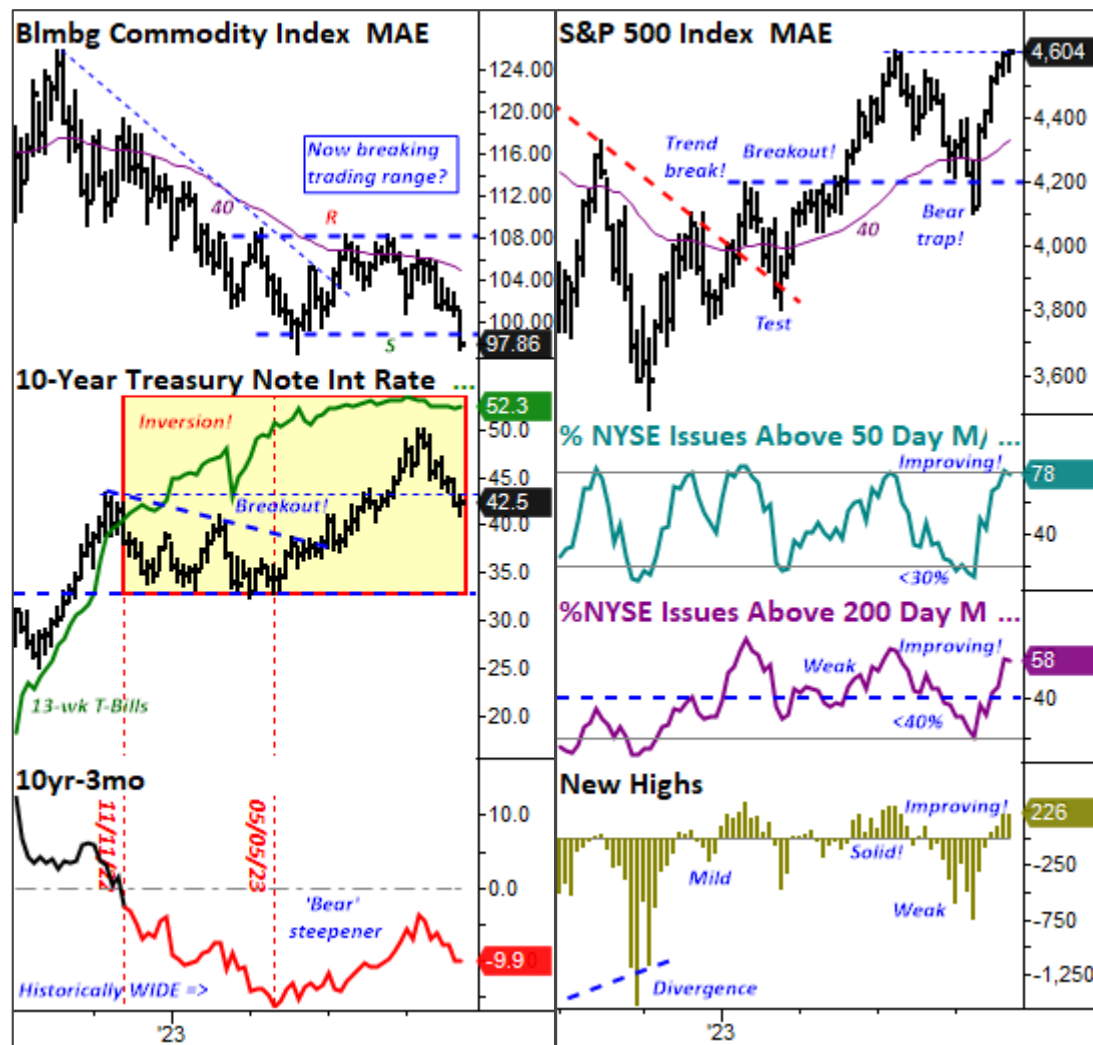
- Commodities in trading range
- Higher rates starting to impact
- Gold responding to mid-east tensions

Yields / Credit:

- 3-mo. T-Bills remain stubbornly firm
- 10-yr. failed at 'round number' of 5%
- Yield curve inverted since Nov'22
- Reliable forecaster of recessions
- Average lead time is 12 mo. (range 5-22)

Stocks:

- Saw a typical 'bear market'
- Looks to have formed cyclical bottom
- Internals finally improving nicely
- Have clearly put a 'bear trap' on chart
